The 49 cases reported today raises the total number of COVID-19 cases to 40,630 in Cameron County. There have also been an additional 72 individuals who have recovered, raising the total number of recovered individuals to 37,753.

Cameron County Public Health has received notification of one (1) additional COVID-19 related death of a Cameron County resident. This raises the total number of COVID-19 deaths in Cameron County to 1,637.
