The 15 cases reported today raises the total number of COVID-19 cases to 40,789 in Cameron County. There have also been an additional 74 individuals who have recovered, raising the total number of recovered individuals to 38,126.

Cameron County Public Health has received notification of one (1) additional COVID-19 related death of a Cameron County resident. This raises the total number of COVID-19 deaths in Cameron County to 1,641.
