Cameron County Public Health does not have any reports of COVID-19 related deaths of Cameron County residents for today. The current total number of COVID-19 death is 1,672.

Cameron County continues the vaccination efforts within our communities. As of today, 58.00% of the population 12 years and older in Cameron County is fully vaccinated and 71.33% has received at least one dose. In addition, 78.27% of the population 65 years and older in Cameron County is fully vaccinated and 87.22% has received at least one dose.
