The 45 cases reported today raises the total number of COVID-19 cases to 42,119 in Cameron County. There have also been an additional 19 individuals who have recovered, raising the total number of recovered individuals to 39,648.

Cameron County Public Health has received notification of two (2) additional COVID-19 related deaths of Cameron County residents. This raises the total number of COVID-19 deaths in Cameron County to 1,685.
