The 38 cases reported today raises the total number of COVID-19 cases to 42,912 in Cameron County. There have also been an additional 59 individuals who have recovered, raising the total number of recovered individuals to 40,216.

Cameron County Public Health has received notification of one (1) additional COVID-19 related deaths of a Cameron County resident. This raises the total number of COVID-19 deaths in Cameron County to 1,699.

Cameron County continues the vaccination efforts within our communities. As of today, 66.20% of the population 12 years and older in Cameron County is fully vaccinated and 77.51% has received at least one dose. In addition, 81.13% of the population 65 years and older in Cameron County is fully vaccinated and 89.11% has received at least one dose.
