Cameron County Public Health does not have any reports of COVID-19 related deaths. of Cameron County residents for today. The current total numbers of COVID-19 deaths is 1,705.

Cameron County continues the vaccination efforts within our communities. As of today, 68.10% of the population 12 years and older in Cameron County is fully vaccinated and 79.97% has received at least one dose. In addition, 81.80% of the population 65 years and older in Cameron County is fully vaccinated and 89.85% has received at least one dose.
