Cameron County Public Health does not have any report of COVID-19 related deaths of Cameron County residents for today. The current total number of COVID-19 deaths is 1,705.

Cameron County continues the vaccination efforts within our communities. As of today, 68.19% of the population 12 years and older in Cameron County is fully vaccinated and 80.16% has received at least one dose. In addition, 81.82% of the population 65 years and older in Cameron County is fully vaccinated and 89.88% has received at least one dose.
