The 44 cases reported today raises the total number of COVID-19 cases to 51,631 in Cameron County. There have also been an additional 29 individuals who have recovered, raising the total number of recovered individuals to 47,313.

Cameron County Public Health has received notification of four (4) additional COVID-19 related deaths of Cameron County residents. All reported deaths were not vaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 1,890.
