The 42 cases reported today raises the total number of COVID-19 cases to 52,777 in Cameron County. There have also been an additional 69 individuals who have recovered, raising the total number of recovered individuals to 48,482.

Cameron County Public Health has received notification of one (1) additional COVID-19 related death of a Cameron County resident. The reported death was unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 1,945.
