The 82 cases reported today raises the total number of COVID-19 cases to 53,984 in Cameron County. There have also been an additional 38 individuals who have recovered, raising the total number of recovered individuals to 50,859.

Cameron County Public Health has received notification of three (3) additional COVID-19 related deaths of Cameron County residents. Of these deaths, one was unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 2,010.

In addition, 88.44% of the population 65 years and older in Cameron County is fully vaccinated and 98.07% has received at least one dose.
