As Cameron County Public Health works with unaccompanied minor shelters and detention centers addressing the COVID-19 cases in their facilities, zero (0) laboratory reports of COVID-19 were reported from the facilities.

The 75 cases reported today raises the total number of COVID-19 cases to 54,799 in Cameron County. There have also been an additional 71 individuals who have recovered, raising the total number of recovered individuals to 51,410.

Cameron County Public Health has received notification of two (2) additional COVID-19 related deaths of Cameron County residents. The reported deaths were unvaccinated. This raises the total of number of COVID-19 deaths in Cameron County to 2,031.
