Consideration and Authorization to Award the Bid to Republic Services, Inc. for Solid Waste Removal Services in the Five (5) Designated Colonias Participating in Cameron and Willacy Counties Colonia Self-Help Center Program. (TDHCA 7220023).

May 1, 2022 Commissioners Court authorized staff to advertise for the Solid Waste Removal Services and open to bids on April 5, 2022. **The bid opening date was extended to April 19, 2022. Only one bid was received from Republic Services, Inc.**

The above referenced contract provides \$700,000 in grant funds to operate Colonia Self-Help Center Program, which includes the solid waste removal services and the reconstruction of seven (7) dilapidated homes of low-moderate income residents located in five (5) designated colonias, which are Olmito, Valle Hermoso, Santa Maria, Arroyo Colorado Estate in Cameron County and Sebastian in Willacy County.

Community Development Corporation of Brownsville (CDCB) was selected by Cameron County Commissioners Court to operate the SHC program.

Attached is copy of newspaper advertisement and relevant bid documents received from Republic Services. On the next Commissioners Court meeting, the contract with Republic Services will be considered.
