**ORDER FOR THE COLLECTION OF INFORMATION REGARDING MENTAL ILLNESS
OR INTELLECTUAL DISABILITY**

On this day, the Court having determined, pursuant Article 16.22 of the Texas Code of Criminal Procedure, that there is a reasonable cause to believe the Defendant, _____, has a mental illness or is a person with an intellectual disability;

IT IS HEREBY ORDERED that Tropical Texas Behavioral Health (TTBH) or Cameron County Sheriff’s Office – Jail Division Mental Health Counselor collect information regarding whether the Defendant has a mental illness as defined by Section 571.003, Health and Safety Code, or is a person with an intellectual disability as defined by Section 591.003, Health and Safety Code, including information obtained from any previous assessments of the Defendant; and

IT IS HEREBY ORDERED that a written assessment of the information collected SHALL be provided to this Court no later than 96 hours after the time an order was issued for a Defendant held in custody or not later than the 30th day after the date an order was issued for a Defendant released from custody. The written assessment MUST include a description of the procedures used in the collection of information and the applicable expert’s observations and findings pertaining to:

1. Whether the Defendant is a person who has a mental illness or is a person with an intellectual disability;
2. Whether there is clinical evidence to support a belief that the Defendant may be incompetent to stand trial and undergo a complete competency examination under Subchapter B, Chapter 46B, of the Texas Code of Criminal Procedure; and
3. Any appropriate or recommended treatment or service.
