- Water Available (water well or water meter)  YES Survey show location of water service  NO (If no is checked, a plat is required).
- Wastewater Available (septic system or sewer tap)  YES (provide current survey showing location of sewer services  NO (If No is checked, a plat is required).
- Notarized Affidavit that states that the person requesting service is **NOT** the land’s subdivider or the subdivider’s agent and states that the subdivided land has not been further subdivided after **September 1, 1995**.
