GUIDELINES FOR CAMERON COUNTY PRE-TRIAL RELEASE

You are **ineligible** for release thru the Pre-Trial Services for the following allegations:

- 1) Any capital offenses: Capital Murder, Murder, Attempted Murder, Aggravated Kidnapping and Aggravated Robbery.
- 2) Any Sex offenses: Aggravated Rape, Rape of a Child, Indecency with a Child, (all offenses against children) and Incest.
- 3) Any person with an extensive criminal record; any person with a prior felony convictions or a person who has a history of failure to appear in court.
- 4) Any person who falsifies any information on his/her Pre-Trial Service application.
- 5) Any person who is charged with the possession for sale or dispensing of any hard drugs such as heroin; or methamphetamine.
- 6) Any person who is not a bona fide resident of Texas or does not live within a 75 mile radius of Cameron County, Texas for two or more years.
- 7) Any person who has a hold for any offense from another jurisdiction, Example: out of county bonds/warrants, USDM detainees, Immigration detainees, etc.
- 8) Any person suspected of having severe mental or emotional problems.
- 9) Any person with an extremely high bond.
- 10) Any person whom the Pre-Trial Officer feels will not appear for court as promised.

EXCEPTION: Any person who does not qualify may receive a Pre-Trial Bond if so ordered by a District, County Court at Law, Magistrate or Justice of Peace Judge.

We are agents of the courts and make our recommendations based on the probability of appearances in court.
