NOTICE TO CAMERON COUNTY RV GUESTS REGARDING 2022 – 2023 WINTER RESERVATIONS FOR ISLA BLANCA, ANDY BOWIE & ADOLPH THOMAE JR. COUNTY PARK

The Cameron County Parks and Recreation Department would like to announce that it will begin accepting online reservations for the 2022-2023 winter season (October – April), beginning August 15, 2022 at 8:00 p.m. Reservations by phone or in-person will be accepted on the following business day, August 16, 2022 starting at 8:00 a.m.

In anticipation of high demand, we strongly urge guests to take advantage of making their reservation online. Please remember, reservations are on a first come, first serve basis. There will be several sites unavailable for the month of October due to road construction. Once the construction is completed, those sites will be released.

This and future notices/updates will be placed on both the Cameron County and Cameron County Parks websites, including the Park's Facebook page. We encourage winter guests to share it with friends, family and neighbors who may not otherwise receive the message via these outlets.

Helpful Online Reservation Tips:

Making a reservation is as simple as entering this new URL link, <https://www.cameroncountytexas.gov/parks-coastal-parks/parks-rv-reservations/> into your web browser and clicking on the Park you wish to stay at. The park's reservation system (BookYourSite) will populate. You will enter the date range, type of RV, and RV length. When you click on the blue button that indicates "Show Availability". The map will then populate with the available sites based on your specifications. Once you click on your site, you will be given the specifications of that site in a small white box on the right-hand side of the map. If you choose that site, please click on the blue reserve button. You will then be prompted to enter required fields of information followed by an option to secure your reservation with a payment. When finished a transaction receipt will be sent to the email you've provided.

- Please note that in order to make a reservation during the months of January & February, guests must reserve a minimum of one calendar month in order for the reservation to be accepted. Weekly and/or daily reservations will NOT be available for these two months. Gap reservations will be released closer to the start of January.
- For guests reserving a month or longer, it is important to note that calendar day to calendar day constitutes a month, and is required to obtain the monthly rate. The 30-day rule is no longer in effect. Anything less will revert to a weekly rate, if a weekly rate applies. If a weekly rate does not apply (January and February), it will revert to the daily rate. Below are some examples of monthly reservations:
 - *For a monthly rate on a one-month reservation, enter July 1st – August 1st or January 17th – February 17th, etc.*
 - *For a monthly rate on reservations spanning multiple months, enter October 1st – December 1st or May 13th – September 13th, etc.*
- Monthly reservations require full payment for the entire month. Multiple month reservations also require payment for one full month. Daily and weekly reservations require full payment for the entire duration of the stay.
- Reservations for Cabanas requires full payment plus a security deposit of \$50. There are no weekly or monthly rates for cabanas.

12 RV sites have been set aside at Isla Blanca Park dedicated solely to daily rentals for the months of January and February. These sites will be available for a maximum stay of two weeks. Because the availability of these sites is during the months of January and February, only a daily rate will apply to these sites. The following sites have been reserved for daily rental only: C-300 | C-301 | C-377 | C-378 | C-379 | C-380 | C-381 | C-382 | C-383 | C-384 | C-408 | C-409
