In addition, Cameron County has received 0 self-reports of at-home testing.

Cameron County Public Health does not have any reports of COVID-19 related deaths of Cameron County residents for today. The current total number of COVID-19 deaths is 2,293.

Cameron County continues the vaccination efforts within our communities. As of today, 83.31% of the population 6 months and older in Cameron County is fully vaccinated and 99.99% has received at least one dose. In addition, 94.10% of the population 65 years and older in Cameron County is fully vaccinated and 99.99% has received at least one dose.
