- 2. Submit 2 sets of floor Plans or a PDF file of plans with application for review
- 3. Add itemized list of services/ food menu if applying for a mobile vending application
- 4. Pick up reviewed plans at 964 E. Harrison Street 2nd Floor, Brownsville, TX
- 5. At the time of pickup of the plan review, pay with check, money order or debit/credit card: "Pay to the order of *Cameron County Fire Marshal*"
- 6. Comply with Fire Marshal Check List prior to setting up FINAL INSPECTION
