Cameron County Public Health does not have any reports of COVID-19 related deaths of Cameron County residents. The current total of COVID-19 deaths in Cameron County is 2,320.

Cameron County continues the vaccination efforts within our communities. As of today, 84.75% of the population 6 months and older in Cameron County is fully vaccinated and 99.99% has received at least one dose. In addition, 95.49% of the population 65 years and older in Cameron County is fully vaccinated and 99.99% has received at least one dose.
