## 100 % County-wide Tax Collection Consolidation

As of September 22, 2021, Cameron County has entered into an inter-local governmental agreement with the last four remaining taxing districts. This makes a total of 86 districts, consisting of 43 taxing districts, 38 street light districts, and five special districts. This agreement established one centralized location where taxpayers can make their tax payments. This step prevents the duplication of services and saves tax dollars for the entities involved. There is no longer a necessity to visit separate offices.

**Online payments** allow taxpayers to pay their taxes by electronic check or credit card in the convenience of their home or office by going to [www.cameroncountytexas.gov/tac](http://www.cameroncountytexas.gov/tac). A service fee of \$2 will be charged to pay a property tax bill using an Internet check in the amount of \$5,000 or less, online check payments over \$5,000 will be charged \$5. Credit and debit cards will incur a 3% convenience fee online and in person. We hope that you will find this website a useful tool.
