#### **1.- Request for clarifications submitted by vendor/participant:**

#### **Question 1**

1) I saw several places in the RFP that reference a "Schedule A" document with a breakdown of the locations. However, the only thing I found close to this is a page titled "Option 1: Commission by Location". This page appears to list the locations requested and the number of machines requested for that location. Could you please confirm if that is correct? If it is, I have 51 machines between 25 different locations.

ANSWER: Yes, the correct wording for this should be "Category" and not Schedule.

#### **Question 2**

2) Based on what I saw, it would appear that the Cameron County Jail is on this list and is requesting 6 machines. Could you please tell me what access requirements would be necessary to service this location?

ANSWER: Awarded vendor will be scanned by Sheriffs representative each time access is required. Detail access requirements will be addressed once a contract is awarded.

#### **Question 3**

3) From everything I've read on this so far, it would appear that the successful vendor will be offering both snack and drink service instead of splitting the contract. Could you please confirm if this is correct? ANSWER :Please refer to page 6 of 47, section 13

#### **Question 6**

6) Will the awarded vendor be expected to have equipment installed and operational by 12/1/2023 per page 11 section E? The reason why I am asking is because my company doesn't keep this many machines in inventory. If we are awarded the contract we would need to order these machines from our equipment dealers. Due to this, it may take us up to 90 days to order, deliver, and install all of the equipment, if we are awarded the contract.

ANSWER: Awarded vendor will have a thirty (30) days after executed contract date to install vending machines County wide.
