#### ADDENDUM NO. 3

### A. PURPOSE AND INTENT

This addendum is issued for the purpose of modifying the plans for the project referenced above. This addendum shall become part of the contract and all contractors shall be bound by its content. All aspects of the specifications and drawings not covered herein shall remain the same. The General Conditions and the Special Conditions of the specifications shall govern all parts of the work and apply in full force to this addendum.

### **B. CLARIFICATIONS**

- A jobsite walkthrough has been scheduled for Thursday November 2<sup>nd</sup>, 2023 at 10:30am.
   Meeting place to start the walkthrough is the main entrance of the Darrell Hester Building located at 2310 US-77 BUS, San Benito, TX 78586. Contractors interested in performing observations to the existing conditions shall bring their own tools, ladders, equipment, etc.
- 2. The substantial Completion Date shall not exceed 18 months after the notice to proceed has been issued.
- 3. Phases of Construction and Coordination:
  - a. The construction work scheduled to be inside the building shall be performed in phases and in a way that will provide the Owner with the ability to relocate the occupants.
  - b. Contractor shall properly barricade the designated areas of construction as necessary to protect the occupants from all construction hazards. In addition, the protected areas shall provide safe access to egresses, corridors or passageways that will allow movement of occupants from one section to the other.
  - c. Contractor will be allowed to work during regular business hours but in strict coordination with Owner's schedule and activities.
