**CAMERON COUNTY IS PLEASED TO ANNOUNCE THE
RIBBON CUTTING AND GRAND OPENING CEREMONY OF THE
CAMERON COUNTY TAX ASSESSOR-COLLECTOR'S SOUTHMOST OFFICE**

Cameron County is pleased to announce the Ribbon Cutting and Grand Opening Ceremony of the Cameron County Tax Assessor-Collector's Southmost Office will be held on Friday, February 9, 2024 at 10:00 a.m. This new tax office will be the 11th Tax Assessor-Collector site in Cameron County, and will be located at 3000 Southmost Blvd. In Brownsville, Texas.

This new Tax Assessor-Collector's Office will be a 3,597 sq. Ft. Building situated on a 1.31 acre tract of land that will service customers via in-person with five teller stations available, and via three drive thru lanes. This facility will have a seating capacity for 52 customers, and will include a state-of-the-art ticketing system to service all customers' needs. The total project cost is \$2,820,000.00.

This location will collect current and delinquent property taxes, allow payment agreements for all delinquent accounts, payment agreements for individuals over 65 years of age, title transfers, motor vehicle renewals, T.A.B.C. license renewal for liquor, wine, and beer, and collections for all new and used car dealership vehicle inventory tax, as well as marriage licenses through the County Clerk's Office. In addition, this location will include two kiosk workstations, one for the County Clerk's Office that will assist with obtaining deed records, and the other for the District Clerk's Office to offer services such as court record information.

This project began in February 2018, when the Southmost water tower was demolished by the utility company. The land was donated to Cameron County by the City of Brownsville and the Brownsville Independent School District.

"On behalf of the Commissioners' Court, I'm very pleased to be celebrating this ribbon cutting and grand opening for our newest Cameron County facility. The southmost area of Precinct No. 1 is a densely populated area that is growing each year. This facility will make conducting business with Cameron County easier for the surrounding communities. I want to thank our Tax Assessor-Collector, Mr. Tony Yzaguirre, Jr., for working diligently to expand into new areas of Cameron County and offering services to best serve our constituency," stated Cameron County Judge Eddie Treviño, Jr.

"I'm very pleased Cameron County is opening this new facility which will allow for a large population of residents to conduct business with the County without having to travel too far from their neighborhoods. Under the leadership of Judge Eddie Treviño, Jr., and County Commissioners, Cameron County has broken ground on many projects all over the county. This office will not only take care of tax office services but will offer additional county services," stated Cameron County Commissioner Precinct 1 Sofia C. Benavides.
