THE BROWNSVILLE NAVIGATION DISTRICT OF CAMERON COUNTY, TEXAS, AS DESCRIBED IN THE INSTRUMENT RECORDED IN VOLUME 842, PAGE 203 OF THE OFFICIAL PUBLIC RECORDS OF CAMERON COUNTY, TEXAS.

3. A GENERAL DESCRIPTION OF THE NATURE OF THE IMPROVEMENTS OR REPAIRS INCLUDED IN THE AGREEMENTS ARE: NEW SHIP AND BOAT MANUFACTURING FACILITIES FOR MILITARY AND COMMERCIAL USE INCLUDING FOUR (4) PHASES AND RELATED INFRASTRUCTURE.
4. THE ESTIMATED COST OF THE IMPROVEMENTS OR REPAIRS IS ESTIMATED TO BE \$3.2 BILLION WITH ESTIMATED PROPERTY TAX VALUES OF \$2.7 BILLION.
