**INTERLOCAL COOPERATION AGREEMENT**

THIS AGREEMENT is entered into between the COUNTY OF CAMERON, TEXAS, hereinafter referred to as "COUNTY" and the TOWN OF COMBES, hereinafter referred to as "TOWN" pursuant to V.T.C.A., Government Code, Chapter 791, cited as the Interlocal Cooperation Act

WHEREAS, Cameron County is a county in the State of Texas;

WHEREAS, the Town of Combes is a general municipality located in Cameron County, Texas;

WHEREAS, Town and County, each pursuant to its statutory and constitutional authority, are responsible for maintenance and improvements of certain public roadways within their respective borders;

WHEREAS, Town and County desire to provide and perform road improvements to Ries Street, Medely Avenue, Holland Street, and Milam Avenue located in the City;

WHEREAS, County has determined that the County will receive a benefit from the proposed improvements to Ries Street, Medely Avenue, Holland Street, and Milam Avenue, that such will serve a county purpose, and that Texas Transportation Code 251.012 permits the expenditure of County funds for such purpose;

WHEREAS, County and Town are authorized to enter into this Agreement pursuant to the Interlocal Cooperation Act, Texas Government Code 791.001 et seq., Section 791032 as well as under the terms of Texas Transportation code 251.012;


WHEREAS, Town, pursuant to Texas Transportation Code 251.012, requests and authorizes the County to perform the work and services described herein within its corporate city limits and to be partially funded by the County.


1.       LOCATION OF PROJECT: Town of Combes, Cameron County, Texas.
2.       WORK AND SERVICES TO BE PERFORMED: Road Improvements to Ries Street, Medely Avenue, Holland Street, and Milam Avenue.
3.       City will be responsible for the materials for the project, with the County providing the labor and equipment. The improvements to Ries Street, Medely Avenue, Holland Street, and Milam Avenue shall be done in accordance to attached plans and specifications, Exhibit A and cost estimates, Exhibit B for Ries Street, Medely Avenue, Holland Street, and Milam Avenue.
4.       The execution and performance of this Agreement by County and Town have been duly authorized by all necessary laws, resolutions, or corporate action, and this Agreement constitutes the valid and enforceable obligations of County and Town in accordance with its terms.
5.       This Agreement constitutes a one-time agreement between the parties and does not constitute a continuing agreement or responsibility for maintenance of Ries Street, Medely Avenue, Holland Street, and Milam Avenue. Any future maintenance for Ries Street, Medely Avenue, Holland Street, and Milam Avenue will be the responsibility of the Town.
6.       Each party agrees to conform to its own applicable laws, regulations, policies, and procedures with

respect to the performance of the work and services under this Agreement. The Agreement shall have no legal force or effect until such time as it is properly adopted and approved by the CAMERON COUNTY COMMISSIONERS' COURT and the TOWN OF COMBES COUNCIL. This agreement shall terminate on completion of the project.

7. The parties agree that the County will be released of any and all duties imposed by this Agreement following completion of the work and service described in this Agreement.
8. All expenditures made under this Agreement will be made from the current revenues of the paying party and under the authority of Texas Transportation Code 251.012.
