The meeting was called to order by Judge Pro-tem Carlos H. Cascos. He then asked Ms. Vivian Benbow, TV Channel 5 News Reporter, to lead the Court and the Audience in reciting the Pledge of Allegiance to the Flag.

**(7) RECEIPT OF BIDS FOR THE SALE OF CAMERON COUNTY, TEXAS, CERTIFICATES OF OBLIGATION, SERIES 1993, IN THE PRINCIPAL AMOUNT OF \$5,500,000.00**

Ms. Rosemary Martinez, Administrative Assistant to the County Judge, called on Mr. Noe Hinojosa, representing the Investment Firm of Estrada Hinojosa and Co., Inc., Dallas, Texas, to open the bids received for the sale of the Certificates of Obligation.

At this time, Mr. Hinojosa commented on the County's Bond Rating increase the previous week, that being a change from an "Baa" to an "A" rating, said bond rating having remained the same since 1982, and added that the two (2) Bond Rating Agencies were very comfortable with the fiscal condition of Cameron County.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Valencia and carried unanimously, approval was given to open bids as received for the sale of Cameron County, Texas, Certificates of Obligation, Series 1993, in the principal amount of \$5,500,000.00.

Mr. Frank Bejarano, Program Development and Management Director, explained that the Housing and Urban Development (HUD) had set aside Technical Assistance Funding for nationwide competition and that the three (3) joint applications between Cameron County and Community Development Block Grant (CDBG) would provide technical assistance to the Cameron Park area. He stated that a Community-based Corporation was being proposed to focus on Housing, Water and Sewer Assistance and Job Training for Cameron Park. Mr. Bejarano explained that CDBG would provide the technical assistance and the County was involved in the application process because, in the future and depending on the results of the technical assistance strategy, the County would have to apply for funds to provide said assistance.

Commissioner Valencia moved that the County Judge be authorized to act in all matters with respect to the Applications for the HUD Technical Assistance Funding for Planning Activities in Cameron Park.

Mr. Kenneth Conway, Parks Director, stated that the Mutual Aid Agreement was developed to address the question concerning Workers' Compensation responsibility when an employee from one (1) entity was injured during the course of providing emergency assistance to another entity.

Upon motion by Commissioner Valencia, seconded by Commissioner Rosenbaum and carried unanimously, the Mutual Aid Agreement between the Cameron County Park System and the Town of South Padre Island for the Police/Ranger Emergency Assistance was approved.

Mr. Robert Ruiz, Project Architect, recommended that the low bid of Bowman Distributing, Harlingen, Texas, be accepted for the roofing of the Sea Ranch Restaurant. He explained that the bid received was in the amount of \$37,979.00 but, through negotiations, the amount was lowered to \$35,800.00 and added that the owner of the restaurant had agreed to fund the \$2,800.00 in order to keep the Project within the budgeted amount of \$33,000.00. He stated that there was a "contingency" of \$2,000.00 within the Contract whereby, should there be any savings, that they be allocated to the owner.

Mr. Andy Cueto, County Engineer, reviewed the platting history for the Los Ranchitos Subdivision and indicated that all the requirements had been met, including the Health Department's standards. He stated that it was the County Engineering Department's opinion that the Subdivision does not require re-platting since it was platted while under the jurisdiction of the City of Primera and he recommended approval.
