The meeting was called to order by Judge Antonio O. Garza Jr. He then asked Ms. JuaNita Brodecky, Rio Hondo resident, to lead the Court and the audience in reciting the Pledge of Allegiance to the Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on June 24, 1994, at 4:27 P. M.:

### (4) PUBLIC HEARING ON THE INCORPORATION OF THE COMMUNITY OF LOS INDIOS

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the Hearing on the Incorporation of the Community of Los Indios was opened for public comment.

Ms. Dylbia Jeffries, County Counsel, stated that the Community of Los Indios had resubmitted the application for Incorporation, and that the fifty (50) signatures on the Petition were confirmed by the Elections Office as registered voters, the community consisted of approximately 850 residents, and the new plat with the correct boundaries was approved by the County Engineer. Ms. Jeffries stated that the criteria met the legal standards and recommended that the election for the Incorporation be set for August 13, 1994.

Upon motion by Commissioner Rosenbaum, seconded by Commissioner Cascos and carried unanimously, the Public Hearing was closed.

### (2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

## (6) AUTHORIZATION TO HOLD A PUBLIC HEARING FOR A CAMERON COUNTY DUNE PROTECTION PERMIT

Commissioner Rosenbaum moved that the Public Hearing for a Cameron County Dune Protection Permit be opened for comment.

The motion was seconded by Commissioner Matz and carried unanimously.

Mr. Andy Cueto, County Engineer, reported that the Application submitted by Ms. Irma Wiley, d/b/a Beach Riding Outpost, that being a horse stable and riding facility, was considered by the Dune Protection Committee. He stated that the Committee inspected the site and noted that no dunes would be altered or destroyed by the proposed activity and the Committee recommended approval of said Application.

Upon motion by Commissioner Cascos, seconded by Commissioner Rosenbaum and carried unanimously, the Public Hearing was closed.

Commissioner Rosenbaum moved that the Cameron County Dune Protection Permit for Ms. Irma Wiley, d/b/a Beach Riding Outpost, be authorized as recommended by the Dune Protection Committee.

The motion was seconded by Commissioner Matz and carried unanimously.

## (7) ACTION SELECTING 1994 TCDP PROJECTS FOR THE COLONIA CONSTRUCTION FUND AND COMMUNITY DEVELOPMENT FUND

Mr. Frank Bejarano, Program Development and Management Director, reviewed the following Project Request Summary for the Colonia and Community Development Fund and highlighted the cost of the Projects and the number of residents to benefit from said improvements:

Commissioner Cascos moved that the Olmito Project for the Colonia Development Fund and Los Cuates

Project for the Colonia Development Fund be selected as the 1994 TCDP Projects.

The motion was seconded by Commissioner Rosenbaum.

There was some discussion concerning other Projects requested and Judge Garza noted that the City of San Benito was requesting funds for the Leal Subdivision Project.

Upon motion duly made by Commissioner Cascos that the Olmito Project for the Colonia Development Fund and Los Cuates Project for the Community Development Fund be selected as the 1994 TCDP Projects, seconded by Commissioner Rosenbaum, the motion carried the following vote:

## (8) AUTHORIZATION TO APPROVE CHANGE ORDER TO ROOFING CONTRACT FOR COUNTY AIRPORT

Mr. Andy Cueto, County Engineer, reviewed the Change Order as requested by the Project Architect for the roofing of the County Airport, in the amount of \$9,870.00 over the Budgeted amount.

Commissioner Cascos moved that the Change Order to the Roofing Contract for the County Airport be approved, in the amount not to exceed \$10,000.00, said funds to be allocated from the Fund Balance.

The motion was seconded by Commissioner Matz and carried unanimously.

The Change Order is as follows:

IN THE MATTER TO ENTER INTO AN ACCELERATED ACQUISITION SCHEDULE FOR THE FIRM FM/509 WITH OF ALLEN.

WILLIFORD, AND SEALS (REJECTED)

Mr. Andy Cueto, County Engineer, explained the need for the Right-of-Way acquisitions before the end of

September, 1994, in order to obtain funding from the Texas Department of Transportation (TxDoT) for the construction

of FM/509 Roadway in 1995.

He stated that the acquisition schedule with Allen, Williford, and Seals was accelerated by ninety (90) days and

that the action increased the cost of the Contract by approximately \$70,000.00. He noted that the amount was still

within the Budgeted amount for the entire acquisition of the Scheduled Project Road Map.

Commissioner Cascos expressed his concern with the additional cost of \$70,000.00 to the County and

suggested that the Cities of Harlingen and San Benito share the cost at \$35,000.00 each.

Commissioner Cascos moved that the County not appropriate the premium from within Project Road Map in

order to accelerate the (FM 509) Project.

The motion was seconded by Commissioner Rosenbaum and the vote was as follows:

**AYE:** Commissioner Rosenbaum and Cascos

**NAY:** Commissioner Matz and Judge Garza.

Judge Garza remarked that the matter would be considered in one (1) week and he hoped that it would be

supported because "it is the right thing to do". He noted that the objective was to keep the Project within the FM

509/590 Budget, and the excess of what was Budgeted would be picked up by the Cities of San Benito and Harlingen.

He stated that it was a Cameron County Project that would benefit the Cities of San Benito and Harlingen, but ultimately

it would benefit the entire County. He added that the County had the opportunity to take advantage of an accelerated

schedule and to work with the Texas Department of Transportation (TDoT) Commissioner in the extension of Loop FM

509/590, which would ultimately afford the County the opportunity to "cash flow" the Bridge at Los Indios.

Ms. Rosemary Martinez, Budget Officer, clarified that the Budget, as present for Project Road Map, was all

inclusive, that being that all the Professional Fees were allocated to each Road, and that the County would not know the

amount spent for Professional Services until the completion of the Projects.

Commissioner Matz questioned the County Engineer as to whether or not he had attempted negotiations with

the Engineering Company concerning the increased cost. He indicated that he was "appalled" that they would request

almost fifty percent (50%) more for the acceleration. He stated that he had a hard time understanding how the increased

costs could be justified and to what extent they were using "local contractors or agents" for the services.

Judge Garza indicated that the County Engineer had negotiated extensively and suggested that the County

Engineer visit with the Commissioner and review the changes and perhaps call the Engineer on said matter.
