At this time, Mr. Pete Blanco, Maintenance Superintendent, stated that there had been funds set aside for said Project but were utilized for purposes other than the renovations to the vault, and added that the renovation project would begin after July, 1997.

Upon motion by Commissioner Peña, seconded by Commissioner Matz and carried unanimously, the renovations to the third floor vault, District Clerks Office at the Cameron County Courthouse, Judicial Building, Brownsville, Texas, were approved.

The motion was seconded by Commissioner Peña and carried unanimously.

(16) APPROVAL OF BOTH THE CAMERON COUNTY ROAD AND BRIDGE AND THE CAMERON COUNTY SHERIFF-S DEPARTMENT ACCIDENT PREVENTION PLANS, IN ACCORDANCE WITH THE TEXAS LABOR CODE, SECTION 411.041, NOTIFICATION OF EXTRA-HAZARDOUS EMPLOYER

Upon motion by Commissioner Peña, seconded by Commissioner Matz and carried unanimously, the Cameron County Road and Bridge and the Cameron County Sheriff-s Department Accident Prevention Plan, in accordance with the Texas Labor Code, Section 411.041, Notification of Extra-Hazardous Employer, were approved.

At this time, Mr. Frank Bejarano, Program Development and Management Director, stated that the adoption of Policies and Guidelines was essential to process Tax Abatement Agreements with companies in the future and added that nine (9) more Reinvestment Zones had been created along with the current Enterprise Zone, which was also by law, considered a Reinvestment Zone. Mr. Bejarano explained that the Tax Abatement Process would have to be negotiated first with the City of Brownsville for those companies in the AReinvestment Zones@ and that the County would only have the option of deciding whether or not to abate the company, and negotiate the duration and amount of property to be abated.

Commissioner Matz clarified that the tax abatement would be on the increase in value of that property and not on the base value of the property, noting that rollback taxes were not included either.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Resolution adopting guidelines and criteria governing Tax Abatement Agreements in the City of Brownsville Reinvestment Zones and/or Enterprise Zones was adopted.
